## **User Agreement**

You acknowledge that Borrower information is confidential. You agree not to disclose any confidential Borrower information and not to contact a Borrower directly for any reason related to an outstanding loan. All communication must be facilitated through WealthyLoop.

You represent and warrant that any capital you use to facilitate loans through our platform originates from a legitimate source.
